Due to a limited number of vendor spaces, applications will be taken on a first paid, first served basis. All vendors will be required to bring their own tables, chairs, table coverings, canopies, signage and display material. Booth spaces must be well represented. Any booth needing electricity must provide their own extension cords and generators. Booth space is 10' x 10'

Confirmation of location and space number will be sent to You prior to the event. Set up time begins at 9:45 am and all booths must be set up by 11:00 am.
