**\*Vendor fee is \$55.00 . There are NO refunds for no shows.**

Eligibility: Food vendors must obtain a County Community Food Event Food Facility permit and abide by all County Health regulations.

**Due to a limited number of vendor spaces, applications will be taken on a first paid, first served basis. All vendors will be required to bring their own tables, chairs, table coverings, canopies and signage. Booth spaces must be well represented. Any booth needing electricity must provide their own extension cords and generators.**

\*Please note there is a \$113.00 County Health Community Food Event Food Facility application fee. DD214 Military and 501 (C) non profit groups are exempt from this fee but still need to fill out an application and obtain an approval from County Health. County Health applications and fees must be submitted and paid to the County Department of Public Health.

**Booth Space is 10' x 10'**

**Confirmation of location and space number will be sent to you prior to the event. Set up time begins at 9:45 am and all booths must be set up by 11:00 am.**

**Deadline: November 18, 2011**

\*Restaurants within the City of Merced Downtown Business Improvement District have participation priority. The Active 20-30 Club of Merced reserves the right to reject any vendor and cancel any application without cause. The Active 20-30 Club of Merced also reserves the right to locate vendors as it sees fit.
